NOTICE TO CONTRACTORS  
CONTRACT FOR  
MARSHALL AVENUE CONCRETE PAVEMENT REPLACEMENT  
& MISC. REPAIR AREAS**

Notice is hereby given that sealed proposals will be received in the office of the City Clerk of the City of South Milwaukee at the Administration Building, 2424 15<sup>th</sup> Avenue, South Milwaukee, WI 53172 **until 11:00 a.m. on Tuesday July 19, 2022**, at which time they will be publicly opened and read for the above public works improvement contract which will include pavement replacement on Marshall Avenue (11<sup>th</sup> to South Chicago) together with other repair locations identified in the contract documents, with the following items of work:

- Concrete Pavement (9") 1,600 S.Y.
- Concrete Pavement Repair Locations 800 S.Y.
- Concrete Curb & Gutter 200 S.Y.
- Concrete Sidewalk & Ramps 300 S.F.
- Quantities of driveway approach, unclassified excavation, base aggregate, and lawn restoration.

The document set describes items and quantities for bid proposal. It is anticipated that a contract will be awarded by the South Milwaukee Common Council by July 19, 2022 and the work shall be complete by October 28, 2022.

Document sets for bidding must be obtained from Quest. There is a non-refundable fee of forty (\$40) dollars per set.

Prequalification forms for 2022 are required to be on file in the Office of the City Engineer for all contractors and subcontractors at least seven (7) days prior to bid opening. Forms are available from the Engineer's Office upon request or on the City's website: <https://www.southmilwaukee.gov/DocumentCenter/View/239/Prequalification-Application-PDF>. The Common Council's decision as to qualification shall be final.

Proposal must be placed in a sealed opaque envelope addressed to: **"City Clerk, City of South Milwaukee, 2424 15<sup>th</sup> Avenue, South Milwaukee, Wisconsin 53172"** and marked **"Proposal for Marshall Avenue Concrete Pavement Replacement & Misc. repair Areas"** If the bid is sent by mail, the sealed envelope shall be enclosed in a separate mailing envelope with the notation **"Sealed Bid Enclosed"** on the face thereof.

The City of South Milwaukee reserves the right to reject any or all bids and waive any informalities in the bidding. No bids shall be withdrawn after the opening of the bids without the consent of the City of South Milwaukee, Wisconsin, for a period of thirty (30) days after the scheduled time for closing bids.

All proposals must be submitted on a form provided for that purpose as issued within the Document Set, together with a certified check or a bid bond not less than five (5%) percent of the bid, payable to the City of South Milwaukee as a guarantee that, if the bid accepted, the bidder will execute and file the contract and a performance bond in the amount of one hundred (100%) percent of the total proposal price within ten (10) working days after the award of the contract. Failure to execute such contract and performance bond shall be cause for forfeiture of the check or bid bond as liquidated damages.
